

## 18 U.S.C. § 2257 Statement

This Statement (“**Statement**”) is made by LumineCore Limited a company established and existing under the laws of the Republic of Cyprus reg. number HE 466730 (“**Company**”) the owner of the website at the domain name <https://www.desirecast.com/> (“**Site**”) outlines compliance with 18 U.S.C. § 2257 (“**2257 law**”).

1. **Exemption.** The Company does not produce any content that contains any visual depictions of actual sexually explicit conduct. The Company limits its handling of this content and only performs activities of transmission, storage, retrieval, hosting, or formatting of material that may depict sexually explicit conduct, all of which material appears on the Site as the result of actions taken by third-party users of the Site. All parts of the Site that contain user-generated material are under the control of the relevant user and Model for whom the Site is provided as an online service by the operator. Under 18 U.S.C. § 2257(h)(2)(B)(v) and 47 U.S.C. § 230(c), the Site’s operator may delete materials appearing on the Site as the result of actions taken by the Site’s users, which materials are considered, in the operator’s sole discretion, to be indecent, obscene, defamatory, or inconsistent with the policies and terms of service for the Site.
  
2. However, the Company:
  1. for every User ascertains at least 18 years of age.
  2. for every Model (1) ascertains, by examination of an identification document containing such information, the Model’s name and date of birth, and requires the Model to provide such other indicia of his or her identity as may be prescribed by regulations;  
  
(2) ascertains any name, other than the performer’s present and correct name, ever used by the performer including maiden name, alias, nickname, stage, or professional name; and  
  
(3) records information obtained while the Model has an active account and one year after the Model account is closed.

3. Models or other producers (providers of Services via the Site) are solely responsible for proper quality of the Service and compliance with applicable laws. Such providers, inter alia, shall solely comply with 18 U.S.C. § 2257 obligations to keep records for visual depictions of actual sexually explicit conduct (as defined 18 U.S.C. § 2256(2)(A) and § 2257A) created or distributed using the Site.
  
4. Without limiting in any way the applicability of the above-stated exemptions, the Company keeps original records described in 18 U.S.C. § 2257 and 28 C.F.R. Part 75 for all materials appearing on the Site that fall in the following categories: (1) marketing and advertising materials that contain visual depictions of actual or simulated sexually explicit conduct, which materials have been acquired or created by the Website's operator to promote the Website; or (2) materials that are not exempt, as described above.
