

Guidelines for Models

Behavior and Conduct Rules on the Platform

1. General Requirements

- Models must be at least 18 years old to work on the platform.
- The identity of the model must correspond with the information on the ID document provided during registration.

2. Streaming and Content Guidelines

- Models may only broadcast from one account at a time.
- All streams must be live; broadcasting or advertising pre-recorded videos or static images as live content is strictly prohibited.
- Violations of these policies can result in account bans, withheld earnings, and deductions from studio earnings (if applicable).
- Maintaining an active microphone and communicating with viewers is strongly encouraged. This helps models maintain a high engagement score.
- Before starting a broadcast, ensure the show type (e.g., Female, Male, Couple) and location tag (Outdoors, Office, etc.) are correctly selected. Tags and attributes must accurately reflect the content of the broadcast to avoid warnings or interruptions.
- Multi-streaming on other platforms is permitted, but all free-to-view streams on other platforms must be stopped before initiating private or exclusive private shows on our platform.
- Using placeholder screens like “BRB” or “Streaming will start soon” in place of actual live content is not allowed.
- Brief absences during a broadcast are allowed for up to two minutes, provided the absence is announced in the public chat. For longer absences, models should go offline.
- Only approved and registered models may appear in broadcasts. Unauthorized individuals are not permitted.
- Streams, photos, and videos must not include watermarks, logos, or messages unless the model owns the copyright.
- Every broadcast must clearly feature the registered model(s). Models may be required to verify their identity during broadcasts using face verification. Failure to complete this process will result in the broadcast being paused.
- Profile and avatar photos must represent the registered model and should not include explicit nudity. Intimate areas must always be covered.
- Models are responsible for ensuring that their broadcast locations comply with local laws and regulations.
- Broadcasting in public areas is permitted only if unregistered individuals are not visible on camera.

3. Strictly Prohibited Activities

- Registering with fake identification.
- Allowing unregistered individuals or minors to appear in broadcasts or recordings.
- Discussing or depicting illegal or inappropriate topics, including minors, incest, bestiality, or any other unlawful content.
- Displaying or referencing animals in a sexual or provocative manner.
- Exhibiting or discussing violence, blood, torture, asphyxiation, or any unsafe activities.
- Referencing or showing feces, urine, vomit, blood, or menstrual fluid.
- Engaging in or facilitating human exploitation, including sexual slavery. Such activities will be reported to authorities.

4. Platform Safety Rules

- The use of illegal substances or being heavily intoxicated during broadcasts is prohibited.
- Discussing or arranging prostitution or escort services is strictly forbidden.
- Models are not allowed to request personal user information or arrange private meetings.

5. Fair Conduct Guidelines

- Usernames must not contain offensive, hateful, or inappropriate content.
- Harassing or scamming users or other models is unacceptable.
- Models must honor agreements made with users regarding tokens and other transactions.
- Soliciting users for personal expenses is not permitted, except through the platform's approved goal features.
- Accepting or requesting payments outside the platform's system is prohibited.
- Collaborating with fraudulent users or participating in scams will result in permanent bans.
- Promoting other platforms, subscription sites, or third-party payment methods is not allowed.

6. Fines and Penalties

- Repeated user complaints can result in termination of the Model's account.
- Violations may lead to temporary suspensions, permanent bans, and forfeiture of earned tokens.
- Models are expected to report any prohibited activities or violations immediately to support.
